A fee of \$40.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

# **Trial Information- Notice to Exhibitors**

Novice A is open to any handler that has not earned a nosework title in any organization and is not a nosework judge or instructor.

Handlers are only allowed to run 1 dog per element (Example 1 dog in novice and 1 in advanced).

A UKC registration number is required to participate in these trials.

## There will be no food available for sale at this trial.

Procedures at this trial will comply with current Iowa Covid-19 recommendations as of the dates of the trial. We are asking that you wear a mask or face shield when out in public, no matter the distance between people. We will have hand sanitizer available in specified spots. Arrangements will be made so that you won't have to wear mask when competing unless you want to. Briefings will be in person, in a line with 6-8 ft between competitors, a quick in and out and back to your car. All competitors will be kenneling out of your car UNLESS you are volunteering your car for the Vehicle Element in which case you will be given permission to kennel your dog and set up a chair in the barn. We will need volunteer vehicles so please let trial chair know as soon as possible. Once the show entries close we will be able to send you a time of arrival email so you can run your elements and leave. This trial will be ran on very minimal volunteer staff so please be attentive. There will be no gallery (which means no videographer either) at this trial to minimize the number of people in the search areas. Move up forms will be in a designated spot and will be gathered throughout the day and given to the secretary by end of trial on Saturday. Move ups will not be allowed on Sunday morning. Move up forms can be found on UKC website or on K9 Sports Club website if you want to print out ahead of time and have ready. You may want to stick a pen in with your gear so we aren't having to disinfect any pens that are shared in the check in and move up process. Thanks for working with K9 Sports Club so we can hold this trial!!



### **Awards and Prizes:**

Placement ribbons will be provided for 1-4 placements in each class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score. New title ribbons will be offered for anyone earning titles.

**From the North or South**: Interstate 35/80 to the Hickman Road exit (US Highway 6, exit 125). West approximately 10 miles to County Road R-16. South (left) on R-16 ¼ mile. Training Center is on the right.

From the East or West: US Highway 6 to County Road R-16 (approximately 10 miles West of the Interstate 35/80 bridge), then South ¼ mile. Or, Interstate 80 to Van Meter exit (#113) then North 4 miles. Seelah is on the left before reaching US Highway 6.
