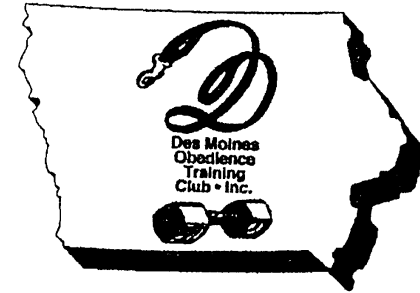

Take I-35 South to US Hwy 30 West. Exit #111B. Take Hwy 30 West to Exit #146 - University Blvd/ISU/Stadium. Go north on University Blvd to South 16th St. Turn east (right) on South 16th to ENTRANCE A. Turn right to Iowa State Small Animal Hospital.

NOTICE TO EXHIBITORS

Bitches in season will be allowed to participate

subject to the conditions set forth in Chapter 2, Section 8 of the Tracking Regulations.
Test Worker Option Two (2) tracks will be reserved for test workers who have worked both days of a DMOTC tracking test within the last 2 years. If necessary, a random drawing may be held to determine which test workers are chosen. The remaining workers will automatically be included in the drawing with all other tracking entries received. Test worker must notify test secretary in writing of intent to be considered for test worker track.

Drawing. The procedures specified in Chapter 1, Section 13, of the Tracking Regulations, shall be observed. A public drawing of entries and assignments of position on the alternate lists will be held at Pagliai's Pizza, 5312 Merle Hay Road, Johnston, IA, 50131 on entry close date at 7 p.m. The Test Secretary will attempt to contact all entrants of the draw results within 48 hours of the drawing, and send the Judging Program by US Mail no less than seven (7) days prior to the test. You may email the Test Secretary after the draw.

Certification With the entry form for a dog which has not passed an AKC Tracking Test, there must be accompanying a written statement, by a person who is accredited by the AKC to judge a Tracking Test, that the dog is considered by the judge to be ready for such a Test. This statement must be dated within twelve (12) months of the date of the Test.

An exhibitor may enter more than one dog. The holding of other titles including "TD" or "TDX" shall not bar a dog from competition in the tests. Entries without a "TD" will be accepted first.

An Alternate List will be maintained. Entry fees will be refunded to alternates who decline to be placed on the Alternate List. Also, entry fees will be refunded to alternates who do not participate in the Test. Entry fees will NOT be refunded to a scheduled entrant who is absent on Test day unless an Alternate is present and runs in place of the absent dog.

Exhibitors will draw to determine the running order for the test. as called for on the face of this premium list, as set forth in Chapter 2, Section 9.

Risk. The owner or agent entering a dog in Tracking Test does so at his/her own risk and agrees to abide by all of the Rules and Regulations of the AKC. The DMOTC assumes no responsibility for any personal property, theft, injury, or death of any animal or loss of or damage to any property while at this Test or the Test site, or in transit to or from the site.

Disaster and Emergency Preparedness Plan, The DMOTC has prepared such a plan for this event and is available to ALL participants upon request, and will be available at the Test site.

Continental Breakfast provided, The site does have a shelter. Restrooms will be available.

Directions to the Test Site. From I-35N or I-35S to Ames, Iowa. Take Exit #116/County Rd E-29/Story County Conservation Ctr. Turn west on CR E29 W/190th Ave to Dayton Ave. Turn north (right) on Dayton Ave to 180th. Turn east (right) on 180th for 1/2 mile to Story County Conservation Ctr located on the north (left) side of the street.
